2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a minireviews of the machine learning for diagnosis of coronary artery disease in CT angiography. The topic is within the scope of the AIMI. (1) Classification: Grade B, Grade C, and Grade D; (2) Summary of the Peer-Review Report: The authors summarized currently existed machine learning algorithms in analyzing coronary CT angiography images and diagnose coronary artery</p>	[Y]

disease, which was well written, and reads well. However, the authors should add some tables and figures, and the questions raised by the reviewers should be answered; and (3) Format: There is no table and figure. A total of 50 references are cited, including 20 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B, Grade B and Grade C. The language was edited by one native English author. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by 7 grants. The topic has not previously been published in the AIMI. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s). 6 Re-Review: Required by Reviewer 00505382 and Reviewer 00397579. 7 Recommendation: Conditional acceptance.
