2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a retrospective study of the endoscopic ultrasound. The topic is within the scope of the WJGE. (1) Classification: Grade B, Grade B and Grade C; (2) Summary of the Peer-Review Report: The subject of this study is important and should be paid attention. The contents are useful for daily medical care. However, there are some issues need to be addressed. In discussion section, the authors</p>	[Y]

should put the focus on the characteristics of pediatric EUS-FNA. The pathologic features of the rectal GIST including cytology, immunostains and mitotic count should be added in the text in the result section. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 3 figures. A total of 16 references are cited, including 2 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A, Grade B and Grade B. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form, the Institutional Review Board Approval Form, and the written informed consent. The authors need to provide the Biostatistics Review Certificate, and the Copyright License Agreement signed by all authors. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJGE. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
