2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: This is a review of the liver injury in COVID-19. The topic is within the scope of the WJG. (1) Classification: Grade B, Grade B and Grade B; (2) Summary of the Peer-Review Report: The authors aimed to review the epidemiological characteristics, etiology, management and preventive strategies of liver injury in patients with COVID-19. The review is well written. Appropriate review in this topic and</p>	[Y]

contribute to increase knowledge in the fast-growing topic and pandemic. However, there are some issues should be addressed. It is unclear whether the virus found in feces may be capable of causing COVID-19. There has not been any confirmed report of the virus spreading from feces to a person. Scientists also do not know how much risk there is that the virus could be spread from the feces of an infected person to another person. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 1 figure. A total of 47 references are cited, including 38 references published in the 2020. There are no self-citations. 2 Language evaluation: Classification: Grade A, Grade B and Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study has 4 financial supports. The topic has not previously been published in the WJG. The corresponding author has published 6 articles in the WJG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); and (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text
