2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a retrospective study of the pyogenic liver abscesses in Mexican population. The topic is within the scope of the WJG. (1) Classification: Grade B and Grade D; (2) Summary of the Peer-Review Report: This is an interesting study. This manuscript</p>	[Y]

presents the current clinical, demographic, and microbiologic characteristics of the pyogenic liver abscess in Mexico. However, there are several points to discuss and clarify in this article. In the “Materials and Methods” section, the criteria for inclusion and exclusion of patients are too simple. Some other very important data, such as the size of the lesion, body mass index, and so on should also be provided in Table 1. Although the author claims to have proof of English language polish, the article still needs further polish. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 2 figures. A total of 30 references are cited, including 5 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade C. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. Written informed consent was waived. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the language classification was grade C.
