The topic is not novel, but it is important and of great importance to physicians who deal with these patients in clinical care. However, there are some issues should be addressed. Please explain the high value of calprotectin in UC patients. Please insert footnote regarding abbreviations used to clarify the data in tables. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 3 figures. A total of 32 references are cited, including 6 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, the informed consent, and the STROBE Checklist form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Sulaiman Al Rajhi University. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please
