Although the conception and data of the present paper could be of some interest, the design and results are sometimes not quite clear, and there are some issues should be addressed. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 1 figure. A total of 26 references are cited, including 11 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade B. The manuscript is from the Canada. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. Written informed consent was waived. No academic misconduct was found in the Bing search. The “abstract” section has been published (https://ascopubs.org/doi/abs/10.1200/JCO.2020.38.4_suppl.317). 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text; and (3) the author
