The study does not involve animals or humans. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Guizhou Provincial Natural Science Foundation. The topic has not previously been published in the WJG.
