The topic is within the scope of the WJG. (1) Classification: Grade B, Grade B, Grade C and Grade E; (2) Summary of the Peer-Review Report: Reviewer# 03756484 thinks this case report describes a very rare</p>	[Y]

liver tumor and does not give some specific revision comments. This is a rare and interesting case presentation of a low grade fibromyxoid sarcoma in the liver of a young man. However, there are some issues should be addressed. Please comment on incidence and poor survival of primary hepatic sarcoma or sarcoma metastasis in the liver. Editorial and language editing is necessary. The questions raised by the reviewers should be answered; and (3) Format: There are 7 figures. A total of 17 references are cited, including 3 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A, Grade B, Grade B and Grade C. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the written informed consent, and the CARE checklist form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJG. The corresponding author has published 2 articles in the BPG. 5 Issues raised: (1) I found the language classification was grade C. Please re-write the “Case Presentation” section, and add “FINAL DIAGNOSIS”, “TREATMENT”, and “OUTCOME AND FOLLOW-UP” section to the main text, according to the Guidelines and Requirements for Manuscript Revision; and (4) the author should number the references in Arabic numerals according to the citation order in the text.
