The topic is within the scope of the WJH. (1) Classification: Grade B, Grade C, and Grade C; (2) Summary of the Peer-Review Report: The authors reported an</p>	[Y]

important and qualified article. However, the number of patients in the study were very low. The figures and tables should be revised. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 5 figures. A total of 31 references are cited, including 3 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A, Grade B and Grade B. The authors stated that the language was edited by a native English speaker. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Clinical Trial Registration Statement, the CONSORT 2010 Statement, the Institutional Review Board Approval Form, and the written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by 1 grant. The topic has not previously been published in the WJCP. 5 Issues raised: (1) The title is too long, and it should be no more than 12 words; (4) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the
