sepsis prognosis. It's a good manuscript in order to work for the future; and (3) Format: There are 6 tables. A total of 53 references are cited, including 15 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, and the informed consent. The authors need to fill out the STROBE checklist with page numbers. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJCCM. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (3) I found the authors did not write the "article highlight" section. Please write the "article highlights" section at the end of the main text; and (4) Please re-write the "abstract" section according to the Guidelines and Requirements for Manuscript Revision. 6 Re-Review: Not required. 7 Recommendation: Conditionally accepted.
