The topic is within the scope of the WJG. (1) Classification: Grade B and Grade D; (2) Summary of the Peer-Review Report: This is a very interesting manuscript. The number of patients who enrolled in the study is relatively large, therefore, the statistical power of the analysis would be robust. However, this report seems to contain</p>	[Y]

fundamental problems in the way of multivariate analysis. In the methods needs clarification regarding the acute liver failure. The questions raised by the reviewers should be answered; and (3) Format: There are 5 tables and 3 figures. A total of 38 references are cited, including 14 references published in the last 3 years. There are 2 self-citations. 2 Language evaluation: Classification: Grade A and Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. Written informed consent was waived. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Fatty Liver Unit, Foundation of the Faculty of Medicine, Chulalongkorn University. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) I found the authors did not
