The topic is within the scope of the WJG. (1) Classification: Grade B, Grade B and Grade C; (2) Summary of the Peer-Review Report: The authors performed a good meta-analysis regarding the evaluation of the efficacy and</p>	[Y]

safety of tacrolimus and mycophenolate mofetil as second-line treatments in AIH. The manuscript is interesting and well written. There is an error in Figure 1. Please revise carefully the English language and check throughout the text for spelling errors. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 5 figures. A total of 53 references are cited, including 6 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade B, Grade B and Grade B. A language editing certificate issued by Science Editor and Translator was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the PRISMA Checklist form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Graduate School of Medical Sciences, University of Groningen, Groningen, the Netherlands; Mohammadreza Abdollahi has a scholarship for his PhD from the Graduate School of Medical Sciences, Groningen University, The Netherlands. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the title was more than 20 words. The title should be no more than 20 words; (2) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or

	<p>funding agency copy of any approval document(s); (3) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (4) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text; and (5) the author should number the references in Arabic numerals according to the citation order in the text.
