2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> 1 Scientific quality: The manuscript describes a retrospective cohort study of the periodontitis on ulcerative colitis. The topic is within the scope of the WJG. (1) Classification: Grade A and Grade A; (2) Summary of the Peer-Review Report: This is a well-designed and well-written up study identifying the</p>	[Y]

relationship between periodontitis and new onset IBD, especially new onset UC, based on national health records. Inclusion or exclusion criteria were described in the text and the results support the conclusion. However, before a final decision is made, some aspects must be addressed. Authors must describe in Abstract the means and standard deviation of age and body mass index, as well as the number of individuals from each gender enrolled in the study. In discussion, the information concerning a putative protective role of smoking on the risk of developing UC must be addressed more carefully using more recent data. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 3 figures. A total of 46 references are cited, including 21 references published in the last 3 years. There are 10 self-citations. 2 Language evaluation: Classification: Grade A and Grade A. A language editing certificate issued by BioMed Proofreading was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. Written informed consent was waived. The authors need to fill out the STROBE checklist with page numbers. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJG. The corresponding author has not

published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text; and (3) please don’t include any \*, #, †, \$, ‡, ¥, @....in your manuscript; Please use superscript numbers for illustration; and for statistical significance, please use superscript letters. Statistical significance is expressed as  $aP < 0.05$ ,  $bP < 0.01$  ( $P > 0.05$  usually does not need to be denoted). If there are other series of P values,  $cP < 0.05$  and  $dP < 0.01$  are used, and a third series of P values is expressed as  $eP < 0.05$  and  $fP < 0.01$ .
