In addition, the questions raised by the reviewers should be answered; and (3) Format: There are 5 tables and 3 figures. A total of 33 references are cited, including 17 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing was performed by an English native speaker. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Copyright License Agreement, the Clinical Trial Registration Statement, CONSORT 2010 Statement, Signed Informed Consent Form(s) and the Institutional Review Board Approval Form. The authors need to complete the Conflict-of-Interest Disclosure Form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the Public Donated Intestine Initiative Foundation; Jiangsu Province Creation Team and Leading Talents Project; National Natural Science Foundation of China; and Top-notch Talent Research Projects. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG.
