2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a minireviews of the post-transplant immunosuppression & COVID-19. The topic is within the scope of the WJT. (1) Classification: Grade C and Grade B; (2) Summary of the Peer-Review Report: This review well summarized the current knowledge on immune interactions of the SARS-CoV-2, the immunomodulatory effects that may be at play, and its relation to the art of immunosuppression. section was Covid-19 & the immune system section, one or two figures were needed to explain the interplay between the virus and the immune system. The questions raised by the reviewers should be answered; and (3) Format: There is no table and figure. A total of 57 references are cited, including 52 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade A and Grade B. The language was edited by an English teacher in the United Kingdom. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. However, the highest single-source similarity index showed to be 6% in the CrossCheck report. The authors need to rephrase the repeated parts. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJT. 5 Re-Review: Required. 6 Recommendation: Conditional acceptance.

Editorial Office Director: I have checked the comments written by the science editor. I suggest that the author should add figures/tables.
