The topic is within the scope of the WJG. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: This is a randomized clinical trail that adds to the growing literature on bowel preparation in children. The overall presentation is logical, the data is well illustrated. The authors need to mention the P value for the comparison between the groups and different</p>	[Y]

medical history of constipation rate between two groups. The time point of participants receiving PEG is not clarified. The authors should use objective items to evaluate the bowel cleanout regimen and discuss the influence of educational level to the efficacy of bowel preparation. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 3 figures. A total of 19 references are cited, including 3 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Conflict-of-Interest Disclosure Form, the Institutional Review Board Approval Form, the Informed Consent Form, Clinical Trial Registration Statement and the CONSORT 2010 Statement. The authors need to provide the Copyright License Agreement signed by all authors. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Ferring Pharmaceuticals Inc. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all

Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please write the “article highlights” section at the end of the main text; and</p> <p>(5) the author should number the references in Arabic numerals according to the citation order in the text.
