The topic is within the scope of the WJG. (1) Classification: Grade C, Grade C, Grade C and Grade D; (2) Summary of the Peer-Review Report: The authors present a case report related to SCCA expression in gastric cancer. This is a good case report as first time being reported; also a good</p>	[Y]

discussion was done. The description of the IHC for SCCA is missing. Magnification of IHC figure on SCCA staining would be beneficial in addition. Some language editing is necessary. Some sentences are not correctly made. The questions raised by the reviewers should be answered; and (3) Format: There are 5 figures. A total of 24 references are cited, including 7 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A, Grade B, Grade B and Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the written informed consent, and the CARE Checklist form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by “The Six Top Talent Project” of Jiangsu Province; National Natural Science Foundation of China; and the Key Laboratory for Laboratory Medicine of Jiangsu Province of China. The topic has not previously been published in the WJG. The corresponding author has published 2 articles in the BPG. 5 Issues raised: I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
