2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a retrospective cohort study of the first-line chemotherapy in very elderly patients with metastatic pancreatic cancer. The topic is within the scope of the WJCC. (1) Classification: Grade B, Grade C, Grade D, and Grade D; (2) Summary of the Peer-Review Report: the</p>	[Y]

authors reported that when the first-line chemotherapy was considered in very elderly patients with metastatic pancreatic cancer, gemcitabine monotherapy is superior for the management of metastatic pancreatic cancer in very elderly patients. This was a potentially interesting report that may affect the first-line chemotherapy in very elderly patients with metastatic pancreatic cancer. However, the manuscript should be major revision according to the comments. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 2 figures. A total of 16 references are cited, including 6 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B, Grade A, Grade B, and Grade C. A language editing certificate issued by editage was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, and the written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCC. 5 Issues raised: The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
