work is very actual, because solitary peritoneal metastasis of GIST is very rare. Work is clearly legible, brings summarizes new knowledge. The citations are actual and their format respect usual standards. This is the first reported case of solitary recurrence GIST in the peritoneum that was treated with complete laparoscopic resection. and (3) Format: There are 5 figures. A total of 18 references are cited, including 1 reference published in the last 3 years, the authors need to update the references. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade C. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: The authors provided the Conflict-of-Interest Disclosure Form, the signed Copyright License Agreement, the signed Informed Consent Form and CARE Checklist (2016). No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) I found the "Case Presentation" did not meet our requirements. Please re-write the "Case Presentation" section, and add "FINAL DIAGNOSIS", "TREATMENT", and "OUTCOME
