2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor: 1</b> Scientific quality: The manuscript describes a basic study of the acute lung-kidney injury. The topic is within the scope of the WJG. (1) Classification: Grade B, Grade B and Grade E; (2) Summary of the Peer-Review Report: Reviewer#02940086 did not give some specific comments in the research content. This is an article that intends to show the effect of a traditional herbal preparation on the prognosis and certain complications of acute</p>	[Y]

pancreatitis. The study has an adequate methodology and the results were discussed appropriately. The results offer an excellent contribution to the study of inflammatory mechanisms in severe acute pancreatitis and its therapeutic possibilities. However, there are some issues should be addressed. Cited papers are generally published in lower-ranked, primarily local journals. The authors need to add more literatures. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 4 figures. A total of 46 references are cited, including 3 references published in the last 3 years. The authors need to update the references. There are 3 self-citations. 2 Language evaluation: Classification: Grade A, Grade A and Grade B. The authors need to provide the language certificate, not the invoice. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Animal Care and Use Committee Approval Form, and the ARRIVE guidelines. The study does not involve humans. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Natural Science Foundation of China. The topic has not previously been published in the WJG. The corresponding author has published 5 articles in the BPG. This manuscript is the resubmission of Manuscript No. 50617. 5 Issues raised: (1) I found the authors did not provide the approved grant

application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not write the "article highlight" section. Please write the "article highlights" section at the end of the main text; (4) please don't include any \*, #, †, §, ‡, ¥, @....in your manuscript; Please use superscript numbers for illustration; and for statistical significance, please use superscript letters. Statistical significance is expressed as  $aP < 0.05$ ,  $bP < 0.01$  ( $P > 0.05$  usually does not need to be denoted).
