The topic is within the scope of the WJG. (1) Classification: Grade B, Grade B, and Grade C; (2) Summary of the Peer-Review Report: The manuscript is a well-written, good</p>	[Y]

structured recommendation for the prognosis of advanced gastric cancer. However, some questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 5 figures. A total of 22 references are cited, including 7 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B, Grade B, and Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, and the written informed consent. The STROBE Statement lacks of the page number. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Akdeniz University Research Foundation. The topic has not previously been published in the WJG. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (4) The "Article Highlights" section is missing. Please add the

	<p>“Article Highlights” section at the end of the main text. 6 Re-Review: Required by Reviewer 02491619. 7 Recommendation: Conditional acceptance.</p> <p>Editorial Office Director: I have checked the comments written by the science editor. There are some issues should be addressed. The abstract is too simple and needs to be expanded. “Materials and methods” section has a large sample size, but the method process description is too simple and needs to be described in detail. The “Discussion” section could also be shortened and focused more. The study was performed without financial support.</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report, the full text of the manuscript and the relevant ethics documents, all of which have met the basic publishing requirements, and the manuscript is conditionally accepted with major revisions.
