The topic is within the scope of the AIMI. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: Suggestion to supplement recent studies applicate machine learning techniques in the multimodal molecular imaging techniques such as PET / CT and PET/MR of pituitary adenomas, and to go through the text, grasp the details and have a little bit of modification; and (3) Format: There are no tables and figures. A total of 39 references are cited,</p>	[Y]

including 19 references published in the last 3 years. There are 3 self-citations. 2 Language evaluation: Classification: Grade B. No language editing certificate was provided. 3 Academic norms and rules: The authors provided the Conflict-of-Interest Disclosure Form and signed Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the AIMI. 5 Issues raised: (1) The highest single-source similarity index should be no more than 6% in the CrossCheck report. The authors need to rephrase any repeated portion of text; and (2) PMID numbers are missing in the reference list. Please provide the PubMed numbers to the reference list and list all authors of the references. Please revise throughout. 6 Re-Review: Not required. 7 Recommendation: Conditional acceptance.

Editorial Office Director: I have checked the comments written by the science editor. The authors need to add some figures and/or tables.
