The topic is within the scope of the WJGO. (1) Classification: Grade B; (2) Summary of the Peer-Review Report:</p>	[Y]

The manuscript is well written, and the topics is interesting and timely, however, several criticisms should be addressed. The miRNAs of 3168, 223-3p, 455-5p, 30c-5p, 584-5p, 30c-5p, 106-3p, 628-3p, 941 do not play a role as biomarkers for HCC development diagnosis. Figure1. Please correct the explanation of the red and green deposits. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 4 figures. A total of 37 references are cited, including 1 reference published in the last 3 years. The authors need to update the references. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by LetPub was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, the informed consent. The authors need to fill out the STROBE checklist with page numbers. No academic misconduct was found in the Bing search. The authors have published preprint (<https://www.researchsquare.com/article/rs-12797/v1>). 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJGO. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text

	<p>portions can be reprocessed by the editor; (2) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (3) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text; and (4) I found the “abstract” did not meet our requirements. Please re-write the “abstract” section according to the Guidelines and Requirements for Manuscript Revision. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.</p> <p><b>Editorial Office Director:</b> I have checked the comments written by the science editor.</p> <p><b>Company Editor-in-Chief:</b> I have reviewed the Peer-Review Report, the full text of the manuscript and the relevant ethics documents, all of which have met the basic publishing requirements, and the manuscript is conditionally accepted with major revisions.
