term prognosis of the patients treated with TACE are highly heterogeneous. Therefore, identification of reliable biomarkers that can be used to predict prognosis of HCC patients would contribute to a more effective clinical management of HCC treatment with TACE. The present study is the first to demonstrate an association between the level of GPC3 and miR-1271 and HCC prognosis after TACE treatment. However, the questions raised by the reviewer should be answered; and (3) Format: There are 5 tables. A total of 42 references are cited, including 20 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade C. A language editing certificate issued by RICHAROSON was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, and the written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript.
