Placing biliary plastic stent balloon dilation was not necessary. It may facilitate stent migration as in this case. (3) Format: There are 3 figures. references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A, B and B. A language editing certificate was waived. 3 Academic norms and rules: The Conflict-of-Interest Disclosure Form should be provided by the corresponding author. Copyright License Agreement was provided. Signed Informed Consent Form(s) or Document(s) was not provided and CARE checklist (2016) were uploaded. No academic misconduct was found in the Bing search and the highest similar index is 24% in the CrossCheck detection, the repeated sentences should be rephrased. 4 Supplementary comments: This is an unsolicited manuscript. Without financial support. The topic has not previously been published in the WJSP. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. And please provide the Table 1 as a three wire table but not a figure. (2) Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. (3) Please re-write the "Case Presentation" section, and add "FINAL DIAGNOSIS", "TREATMENT", and "OUTCOME AND FOLLOW-UP" section to the main text, according to the Guidelines and Requirements for Manuscript Revision. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
