practice in colonoscopy in the near future. Despite being easy to read with adequate organization and presentation the manuscript must be extensively revised and the language significantly improved. There are many spelling, grammar and syntaxes mistakes. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 2 figures. A total of 42 references are cited, including 17 references published in the last 3 years. There are 6 self-citations. 2 Language evaluation: Classification: Grade C. The authors need to provide the language certificate of professional language company. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study is without financial support. The topic has not previously been published in the WJG. The corresponding author has published 2 articles in the BPG. 5 Issues raised: (1) I found the language classification was grade C.
