The topic is within the scope of the WJG. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: This will be an important contribution to the</p>	[Y]

limited data that is available on the subject. It is clear from this review that this is a safe and efficacious treatment for symptomatic pancreatic duct stones. Parsing out the outcomes between first-line POP and second-line POP would be very interesting. The reviewer suggests the authors to add this in the manuscript. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 8 figures. A total of 37 references are cited, including 12 references published in the last 3 years. There are 3 self-citations. 2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the PRISMA Checklist form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. There is no grant support associated with this research project and no financial arrangement disclosure. The topic has not previously been published in the WJG. The corresponding author has published 1 article in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text; and (3) the author should number the references in Arabic numerals according
