2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a retrospective study of the palliative therapies in metastatic esophageal cancer. The topic is within the scope of the WJGS. (1) Classification: Grade B; (2) Summary of the Peer-Review Report:</p>	[Y]

The study addresses the impact of palliative treatments in patients with esophageal carcinoma not undergoing chemotherapy. The study is clear, well-structured and well-written. The purpose is well identified. Appropriate methods and statistics. However, there are some issues should be addressed. The concept of palliative treatment is confusing and needs to be expressed more clearly. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 1 figure. A total of 34 references are cited, including 11 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and the signed Conflict-of-Interest Disclosure Form. The authors need to provide the Copyright License Agreement signed by all authors. Institutional Review Board Approval Form and the informed consent were not required. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study is without financial support. The topic has not previously been published in the WJGS. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor;

	<p>(3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (4) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.</p> <p>Editorial Office Director: I have checked the comments written by the science editor.</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report, the full text of the manuscript and the relevant ethics documents, all of which have met the basic publishing requirements, and the manuscript is conditionally accepted with major revisions.
