The topic is within the scope of the WJG. (1) Classification: Grade C and Grade D; (2) Summary of the Peer-Review Report: This study addresses a clinically relevant question and results add real-world data about the effectiveness of direct-acting antiviral agents in</p>	[Y]

patients treated with methadone. However, it is unclear whether the population enrolled in this study represents a limited, very selected, part of the population of ex-drug users, suffering from chronic HCV infection. If the authors are able to clarify on the selection process of the studied population, it would be a really significant and valuable contribution to the paper. Moreover, they should better explain which would be the reason of this low treatment rate in the different subgroups. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 3 figures. A total of 26 references are cited, including 9 references published in the last 3 years. There are 2 self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by BioMed Proofreading LLC was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, and the informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. The authors need to fill out the STROBE checklist with page numbers. 4 Supplementary comments: This is an unsolicited manuscript. The study was performed with 8 financial supports. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved
