Summary of the Peer-Review Report: The authors deliver a very well written and comprehensive manuscript about artificial intelligence for the detection of colorectal lesions. The article methodically goes through this technology and its progress in field of colorectal polyp detection. The content of the review is comprehensive, and the language of the manuscript needs minor polishing. In the section about artificial intelligence, it would be helpful to add a figure to demonstrate the different layers of the neural network. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 1 figure. A total of 62 references are cited, including 33 references published in the last 3 years. There are 3 self-citations. 2 Language evaluation: Classification: Grade A, Grade A, Grade B and Grade B. The authors provided a personal language certificate. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study is without financial support. The topic has not previously been published in the WJG. The corresponding author has published 1 article in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) I have changed
