2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a basic study of the metallic biliary stents eluting gemcitabine and cisplatin for extrahepatic cholangiocarcinoma. The topic is within the scope of the WJG. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: The authors carried out this experimental study, which is of great clinical importance. The study is</p>	[Y]

informative and well-written. However, there are some issues should be addressed. In the method, it is possible to observe the presence of some biases. The number of pigs included to the study is too low (6 in each group) to make a conclusion. The authors used FC stents and fixed them on the bile duct wall with 5.0 suture to avoid stent migration. However, this does not correspond to clinical practice since non-covered stents are used to prevent migration and acute cholecystitis. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 5 figures. A total of 34 references are cited, including 2 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade B. The authors provided a personal language certificate. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Copyright License Agreement, and the Institutional Animal Care and Use Committee Approval Form. The authors need to provide the Institutional Review Board Approval Form, complete the Conflict-of-Interest Disclosure Form, and fill out the ARRIVE checklist form with page numbers. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Natural Science Foundation of China; and the Science and Technology Development Funds of Shanghai of China. The topic has not previously been published in the WJG. The corresponding author has not published articles in the
