2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: This is a minireview of the Gallbladder wall thickening. The topic is within the scope of the WJG. (1) Classification: Grade B, Grade B and Grade B; (2)</p> <p>Summary of the Peer-Review Report: The manuscript is a well written, comprehensive review and provides appropriate discussion on utility of imaging features in GB pathologies.</p>	[Y]

However, there are some issues should be addressed. Since this review emphasized on GB wall thickening, the definition of GB wall thickening is mandatory for background and introduction. Suggest replacing CEUS example with any better reference image if possible. The authors need to explain how to incorporate the role of intervention radiology in this review article. The questions raised by the reviewers should be answered; and (3) Format: There are 5 tables and 12 figures. A total of 72 references are cited, including 22 references published in the last 3 years. There are 2 self-citations. 2 Language evaluation: Classification: Grade A, Grade B and Grade B. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study is without financial support. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. 6 Re-Review: Required. 7
