<b>Patient Information</b>	<b>6a</b>	De-identified demographic and other patient or client specific information	<u>29/4</u>

<b>Physical Exam</b>	<b>7</b>	Relevant physical examination findings	<u>14/5</u>
<b>Diagnostic Assessment</b>	<b>8a</b>	Evaluations such as surveys, laboratory testing, imaging, etc.	<u>20/5</u>
