evaluated a very useful topic. In general, this is a good review and analysis of a little considered problem in diagnostic tissue acquisition for cancer patients. However, there are some issues should be addressed. EUS-TA is still the best option we have to obtain tissue samples in the setting of GI wall or pancreatic lesions. Percutaneous US or TC guided approaches are far less efficient with higher risk of seeding, as reported in literature. The reviewer would suggest address this topic in discussion. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables. A total of 70 references are cited, including 21 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A, Grade B and Grade C. A language editing certificate issued by Scientific Writing Solutions was provided. The language needs to be further improved. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form. Please confirm the author list (the author list of the manuscript is not consistent with the author list of Copyright License Agreement). No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Project of Guangdong Medical Research Fund; Technical Research and Development Project of Shenzhen; and the National Natural Science Foundation of China. The topic has not previously been published in the WJG. The corresponding author has published 3 articles in the BPG. 5 Issues raised: (1) I found the
