TIPS in the management of in portal hypertension patients with cirrhosis with emphasis on emerging indications of TIPS, evolving patient selection criteria, and technical aspects of the procedure, put forward future prospective in the end. There are no data regarding TIPS complications including stent migration, difficulties during stent placement, difficulties during portal vein access, difficulty faced during portal vein localization. Moreover, the information about the patency time of TIPS is lacking. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 7 figures. A total of 251 references are cited, including 47 references published in the last 3 years. Please provide the original figure documents.
