A total of 20 references are cited, including 1 reference published in the last 3 years. The authors need to update the references. There are no self-citations. 2 Language evaluation: Classification: Grade B, Grade B and Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, the informed consent, and the STROBE Checklist form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Natural Science Foundation of China (General Program); Beijing Municipal Science & Technology Commission; and the Capital's Funds for Health Improvement and Research. The topic has not previously been published in the WJG.
