2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> 1 Scientific quality: The manuscript describes a retrospective study of the effects of proprotein convertase subtilisin/kexin type – 9 inhibitors on fatty liver. The topic is within the scope of the WJH. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The authors shows an interesting result that potentially opens a way to establishing an effective medication therapy for NAFLD (or MAFLD). well-written, and demonstrates their results sufficiently to introduce the present conclusion. However, some questions raised by the reviewer should be answered; and (3) Format: There are 3 tables and 1 figure. A total of 28 references are cited, including 7 references published in the last 3 years. There are no self-citations.

2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form, and the Institutional Review Board Approval Form. Written informed consent was waived. The Copyright License Agreement lacks of the signature of all authors. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Clinical and Translational Science Award. The topic has not previously been published in the WJH. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
