The topic is within the scope of the WJCO. (1) Classification: Grade A and Grade C; (2) Summary of the Peer-Review Report: The authors reviewed fluopyrimidines-induced cardiotoxicity perfectly, collectively. However, the newer references and a schematic figure should be added; and (3) Format: There are 2 tables. A total of 63 references are cited, including 8 references published in the last 3</p>	[Y]

years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by PaperTrue Editing and Proofreading Services was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCO. 5 Issues raised: (1) The “Author Contributions” section is missing. Please provide the author contributions; and (2) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.

Editorial Office Director: I have checked the comments written by the science editor. I have changed the manuscript type “review” to “minireview”.
