shorten. However, the manuscript was based on a descriptive analysis. Regarding PUFA and fiber, it is easier to understand the effect of IBD on mucosal immunity with a figure. The questions raised by the reviewer should be answered; and (3) Format: There are 2 figures. A total of 114 references are cited, including 6 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Funding for Education, Research and Extension Support (FAEPEX) - University of Campinas. The topic has not previously been published in the WJEM. 5 Issues raised: (1) The authors did not provide the approved grant application form(s).
