Summary of the Peer-Review Report: The authors reported an interesting topic. However, contents of this article are difficult to understand because of insufficient evidences. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables. A total of 30 references are cited, including 3 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B, Grade B and Grade B. A language editing certificate issued by editage was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Copyright License Agreement, the STROBE Statement, and the Institutional Review Board Approval Form. Written informed consent was waived. The Conflict-of-Interest Disclosure Form is not qualified. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by Coordenação de Aperfeiçoamento de Pessoal de Nível Superior. The topic has not previously been published in the WJH. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) The authors did not provide original pictures. Please provide the original PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the

Please add the “Article Highlights” section at the end of the main text; and (5) Please add only one corresponding author’s information. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.</p> <p>Editorial Office Director: I have checked the comments written by the science editor.
