The topic is within the scope of the WJGS. (1) Classification: Grade B, Grade B, Grade C, Grade D, and Grade C; (2) Summary of the Peer-Review Report: The authors presented a case of an intramural gastric nodule mimicking a gastric</p>	[Y]

gastrointestinal stromal tumor (GIST), which should be valuable for diagnose of intramural gastric nodule. However, the author needs to do a systematic literature review. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 2 figures. A total of 31 references are cited, including 5 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B, Grade B, Grade B, Grade B, and Grade B. The language was edited by one native English speaker. 3 Academic norms and rules: The authors provided the CARE Checklist-2016, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJH. 5 Issues raised: (1) The “Author Contributions” section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (4) The “Case Presentation” section was not written according to the Guidelines for Manuscript Preparation. Please re-write the “Case Presentation”

	<p>section, and add the “FINAL DIAGNOSIS”, “TREATMENT”, and “OUTCOME AND FOLLOW-UP” sections to the main text, according to the Guidelines and Requirements for Manuscript Revision. 6 Re-Review: Required by Reviewers 05226166, 02524651, and 03726743. 7 Recommendation: Conditional acceptance.</p> <p>Editorial Office Director: I have checked the comments written by the science editor.
