(1) Classification: Grade A and Grade D; (2) Summary of the Peer-Review Report: The findings that VAP-1 deficiency reduced lipid accumulation in the hepatocytes is interesting. mechanism remains unknown. The appropriate statistical analysis should be provided. The questions raised by the reviewers should be answered; and (3) Format: There are 6 figures. A total of 61 references are cited, including 6 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade B. The author is a native English speaker. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, the Institutional Animal Care and Use Committee Approval Form or Document. The ARRIVE Guidelines is not right. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by 1 grant. The topic has not previously been published in the WJH. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide the approved grant application form(s).
