propensity match your cases based on TNM stage to ensure similar tumor types and then re-run the statistics to ensure that the results hold true that PRFA outperforms HR for tumors of a similar size, location, number and distribution. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 2 figures. A total of 22 references are cited, including 6 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Two Grades B.
