(1) Classification: Grade C; (2) Summary of the Peer-Review Report: This is an interesting study evaluating the value of DCE-MRI and DWI in assessing Crohn's disease activity. understood that combining DCE-MRI parameters and ADC would be of use to differentiate inactive CD from active CD, but we couldn't understand how they combine information of DCE-MRI parameters and ADC. The authors need to add more details in the "method" section. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 6 figures. A total of 36 references are cited, including 5 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Copyright License Agreement, the Institutional Review Board Approval Form, and written informed consent. The authors need to complete the Conflict-of-Interest Disclosure Form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the Medical Innovation Program of Fujian Province; and Startup Fund for scientific research of Fujian Medical University. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the title was more than 20 words. The title should be no more than 20 words; (2) I found no "Author contribution" section. Please provide the author contributions; (3) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or

funding agency copy of any approval document(s); (4) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (5) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (6) I found the authors did not write the "article highlight" section. Please write the "article highlights" section at the end of the main text; (9) I found no "Abstract" section. Please write the "Abstract" section. 6 Re-Review: Not required. 7 Recommendation: Conditionally accepted.
