The topic is within the scope of the WJGS. (1) Classification: Grade B and Grade B; (2) Summary of the Peer-Review Report: The authors reported an interesting and a very detailed study of the comparison of TP with partial</p>	[Y]

pancreatic resection for PDAC. However, the introduction and technique sections should be shorten. The language needs improvement in all sections. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 6 figures. A total of 58 references are cited, including 11 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade A. A language editing certificate issued by Medjaden Bioscience Limited was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. Written informed consent was waived. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJGS. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
