The methods section seems well described, statistical analysis seems adequate. The discussion is formed properly. The conclusion that an increased EPCs and CECs mobilization after maximal exercise in CHF patients. However, some data should be added in the statistical analysis; and (3) Format: There are 4 tables and 2 figures. A total of 34 references are cited, including 4 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. The authors didn't provide the language certificate. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, the Written informed consent, and the CONSORT 2010 Statement. The Clinical Trial Registration Statement is not qualified. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The manuscript was supported by two grants. The topic has not previously been published in the WJC. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) The "Article Highlights" section is missing. Please add the "Article Highlights"
