The topic is within the scope of the WJCC. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: This manuscript is a rare case report describing the hernioplasty for pelvic floor hernia treated with laparoscopic surgery with perineal approach. manuscript is that the combination of the biological mesh and pedicle skin flap with both laparoscopic and perineal approach was useful and safety procedure to estimate the orifice bidirectionally. The questions raised by the reviewers should be answered; and (3) Format: There is 1 figure. A total of 23 references are cited, including 3 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. 6 Re-Review: Not required. 7 Recommendation: Conditional acceptance.
