The topic is within the scope of the WJCP. (1) Classification: Grade C and Grade D; (2) Summary of the Peer-Review Report: This study is interesting. However, major revisions are needed for publication. Virologic features of influenza B should be described; the differences of influenza A and B in epidemiology, virology, host factor, clinical features, treatment, prognosis, vaccine, etc. should be summarized</p>	[Y]

in a table; Moreover, figures should be used to help reader to understand this article; and English should be improved. (3) Format: A total of 27 references are cited, including 13 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by Grammarly was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, No academic misconduct was found in the Bing search. The highest single-source similarity index in the CrossCheck report showed to be 10%. The CrossCheck results showed the similarity to be high. According to our policy, the overall similarity index should be less than 30%, and the single-source similarity should be less than 5%. Please rephrase these repeated sentences. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJCP. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
