(3) Format: 1 figure and 1 table. 16 references were cited, including 6 references published in the last three years. No self-citation. 2</p>	[Y]

Language evaluation: Grade B and C. Language editing certificate was not provided correctly, please provide language certificate by language editing company. 3 Academic norms and rules: The conflict-of-interest disclosure form and Copyright License Agreement were provided. No academic misconduct was found in the Bing search and the single similar index is 7% in the CrossCheck search, the repeated sentences should be rephrased. 4 Supplementary comments: (1) Invited manuscript. (2) Without financial support. (3) Corresponding author has not published articles in BPG. 5 Issues raised: (1) Please provide the author contributions. (2) Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. (3) The number of references is too small for a review, please add more references. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
