The topic is within the scope of the WJH. (1) Classification: Grade D and Grade C; (2) Summary of the Peer-Review Report: The authors focused an important data for the follow-up of patients</p>	[Y]

after liver transplantation. However, the authors should extensively improve the paper, the language should be polished. The questions raised by the reviewers should be answered; and (3) Format: There are 5 tables. A total of 25 references are cited, including 5 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by Copy Editing & Translating Services was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. Written informed consent was waived. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by 1 national grant and 2 provincial grants. The topic has not previously been published in the WJH. 5 Re-Review: Required. 6 Recommendation: Conditional acceptance.
